1. Individuals may contribute up to \$2,500 per election. Contributions from corporations, foreign nationals, national banks, and federal government contractors are prohibited. Contributions must be made from personal funds and may not be reimbursed by any other person. Contributions are not deductible as charitable contributions for federal income tax purposes.

2. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and name of employer of individuals whose contributions exceed \$200 in an election cycle.
