**SMALL MOUTH BASS** - 1ST, 2ND, 3RD BASED ON LONGEST FISH

**NOTE:** ANGLERS ARE ELIGIBLE FOR ALL EVENTS (2 MAXIMUM TOP THREE PLACEMENTS PER ANGLER AND ONLY 1 PLACEMENT IN EACH CATEGORY). ALL ANGLERS ARE REQUIRED TO **BRING PERSONAL DIGITAL CAMERA AND TOURNAMENT RULER** (EX: GOLDEN RULE, RAPALA, PLANO, BERKLEY RULERS ARE ALL ACCEPTABLE) FOR PHOTOGRAPHING CATCH (PLEASE BE SURE TO BRING THE USB CABLE FOR CAMERA TO AVOID PROBLEMS WITH SD CARD). 1 PHOTO PER FISH, FISH MUST BE PHOTOGRAPHED WITH MEASURED LENGTH CLEARLY DEFINED BY USE OF RULER, AND EVENT CARD (CLOSED MOUTH AND PINCHED TAIL ARE ALLOWED, EVENT CARD WILL BE HANDED OUT PRIOR TO TOURNAMENT). PHOTO'S WILL BE VERIFIED BY TOURNAMENT OFFICIALS FOR EVENT CARD AND FISH IDENTITY TO INCLUDE MARKINGS.

**PAYOUT:** 50% OF TOTAL ENTRY FEES (\$17 PER PERSON) WILL BE PAID OUT WITH PRIZES. THE OTHER 50% OF THE ENTRY FEE WILL PAY FOR TOURNAMENT T-SHIRTS, FOOD, AND OTHER EXPENDITURES. PRIZES WILL BE DISPLAYED AT THE START OF THE TOURNAMENT, AND BASED ON THE NUMBER OF ENTRIES. **ALL TOP 3 PRIZES THAT ARE NOT FILLED WITH A CATCH WILL BE RAFFLED OFF.**

**LEGAL TACKLE / BAIT:** ANY HOOK AND LINE COMBINATION IS ALLOWED. ARTIFICIAL BAIT ONLY (NO LIVE BAIT).

**PADDLE / PEDDLE CRAFT ONLY:** (NO TROLLING MOTORS/ SAILS/ GAS ENGINES/ "MOTHER SHIPS") AS WELL AS BEING ABLE TO FISH FROM YOUR KAYAK YOU ARE ALLOWED TO WADE FISH OR FISH FROM THE BANK. AS LONG AS THAT AREA YOU ARE WADE FISHING OR FISHING FROM THE BANK IS WITHIN 100 FT. AND VIEW OF YOUR **LAUNCHED CRAFT. MINORS WILL BE ALLOWED TO FISH FROM THE BANK WITHOUT A KAYAK AND MUST BE REGISTERED.**

**WATER COURTESY:** DO YOUR BEST NOT TO DISTURB SOMEONE ELSE'S FISHING AREA, BY ENCROACHMENT, OR NOISE. IF YOU COME UPON AN ANGLER IN AN EGRESS AREA, QUIETLY ASK WHICH SIDE HE OR SHE WOULD LIKE YOU TO CROSS AT. ( GOOD RULE OF THUMB, IF YOU CAN BOTH CAST TO A COMMON POINT YOU ARE TOO CLOSE)

**PROTEST:** ALL PROTESTS MUST BE MADE IN WRITING AND DELIVERED TO A TOURNAMENT OFFICIAL WITHIN 30 MINUTES OF THE CHECK - IN TIME. THE TOURNAMENT DIRECTOR IS THE FINAL AUTHORITY IN ALL CONSIDERATIONS.

**RELEASE OF LIABILITY AND COVENANT NOT TO SUE:** A WAIVER, RELEASE OF LIABILITY, AND COVENANT NOT TO SUE ARE PART OF THE ENTRY FORM. IT IS REQUIRED THAT ALL CONTESTANTS TAKE RESPONSIBILITY FOR THEMSELVES WHILE PARTICIPATING IN EVENT ACTIVITIES.

**PRE - REGISTRATION:** EACH CONTESTANT MUST PRE - REGISTER AND PAY BY 10 JULY 2011.

ENTREE FEES INCLUDE TOURNAMENT T-SHIRT AS WELL AS A POST TOURNAMENT MEAL. EXTRA SHIRTS CAN BE PURCHASED FOR \$20 HOWEVER QUANTITY AND SIZES MUST BE SPECIFIED AT THE TIME OF REGISTRATION. IF YOU ARE ORDERING EXTRA SHIRTS INCLUDE THAT AMOUNT IN ADDITION TO YOUR REGISTRATION FEE.

**LEGAL FISH TIME / BOUNDARIES:** 0630 AM - 1230 PM WEIGHT IN 30 JULY 2011. ALL FISH MUST BE CAUGHT IN ACCORDANCE WITH COLORADO STATE LAWS.

ALL WATER WITHIN UNION RESERVOIR IS LEGAL FOR TOURNAMENT.

SIGN IN / WEIGH IN: THE SIGN IN / WEIGH IN STATION WILL BE OPERATIONAL STARTING AT 1130 AM, AND WILL RUN TILL ALL ANGLERS HAVE SIGNED IN BY THE 1230 PM DEADLINE. ANY ANGLER SIGNED IN BY THE 1230 DEADLINE WILL HAVE THE OPTION TO ENTER THEIR CATCH. ANY ANGLER THAT DOES NOT SIGN IN BY THE 1230 DEADLINE WILL BE DISQUALIFIED AND WILL NOT BE ELIGIBLE FOR TOURNAMENT PLACEMENT. THERE WILL BE NO EXCEPTIONS FOR THIS RULE. OFFICIAL TIME WILL BE KEPT BY THE TOURNAMENT DIRECTORS AT THE WEIGH IN STATION. ANGLERS ARE URGED NOT TO WAIT UNTIL THE LAST MINUTE TO SIGN IN FOR PICTURE SUBMISSION. **WEIGH IN TIME IS THE TIE BREAKER.**

WEIGHT IN WILL START A SHORT TIME AFTER THE 1230 DEADLINE HAS PASSED. THE WEIGH MASTER WILL MAKE DECISIONS ON ACCEPTING PHOTO'S, THEIR DECISION IS FINAL. ANY ATTEMPT TO ENTER FRAUDULENT CATCH, EXCHANGING CATCHES, TAMPER WITH CATCH, OR HAMPER OR THREATEN ANY OFFICIAL OF THE TOURNAMENT WILL RESULT IN IMMEDIATE DISQUALIFICATION. ONLY AUTHORIZED PERSONNEL WILL BE ALLOWED IN OFFICIAL'S AREA. EACH CAMERA'S PHOTOS WILL BE ENTERED INTO OFFICIAL COMPUTER AND GIVEN A NUMBER FILE IN ACCORDANCE WITH THE NUMBER GIVEN TO THE ANGLER. ALL CAMERA EQUIPMENT WILL BE IMMEDIATELY RETURNED TO ANGLER WITH COPIES OF PHOTOGRAPHS, ( **SD CARDS ARE ALLOWED FOR ENTRY BUT BE SURE TO BRING CAMERA USB CABLE TO ASSURE THERE WILL BE NO COMPLICATIONS WITH SIM CARD**) ALL DOWNLOADED PHOTOGRAPHS WILL BECOME PROPERTY OF THE TOURNAMENT DIRECTOR, ORIGINAL COPIES OF PHOTOGRAPHS WILL BE PROPERTY OF ANGLER.

**EVENTS DURING TOURNAMENT:** EVENT DIRECTOR WILL BE HOSTING KAYAK, AND PADDLE BOARD DEMO'S.

**FAMILY FRIENDLY EVENT:** THIS EVENT IS A FAMILY FRIENDLY ATMOSPHERE, THERE WILL BE FOOD, FUN, AND ENTERTAINMENT. PLEASE BRING YOUR FAMILY TO ENJOY THE DAY WITH.
