

Agreement, Release and Waiver of Liability

La Liga Indoor Soccer Club

In consideration of being permitted to participate in or assisting others in participating in the La Liga Indoor Soccer Club and related events and/or activities, on behalf of myself, or a minor child or ward, her, next of kin, personal representative.

(1) I ACKNOWLEDGE, UNDERSTAND, DECLARE AND AGREE THAT

(a) To the best of my knowledge, I am in Good Physical Condition and have no disease or injury that would be aggravated by participating in activities to the League.

(b) Participating or assisting others in participating in the League may involve RISK OF INJURY TO ME, INCLUDING DEATH, LOSS OR DAMAGE TO ME OR MY PROPERTY, or other consequences, which might result not only from my own actions, inaction or negligence but also the actions, inaction or negligence of others, the rules of play, or the conditions of the premises or of any equipment used.

(c) There may be OTHER RISKS not known or not reasonably foreseeable; and Understanding All of the above.

(2) I ASSUME ALL OF THE ABOVE RISKS AND RELEASE, WAVE, DISCHARGE, HOLD HARMLESS, INDEMINIFY AND COVENANT NOT TO USE.

(a) The United State Soccer Federation (USSF), the State of Florida or any of its agencies, The Florida State Soccer Association (FSSA), the La Liga Indoor Soccer Club, LLC (LLISC), its commissioners, employees or volunteers, coaches, trainers, officials affiliated with the organizations, players involved in the games or not, agencies, sponsors, or advertisers, the respective administration, officers, directors, agents, representatives, employees, volunteers, coaches, trainers, officials or any other individuals affiliated with the league.

(b) Any affiliated subsidiary, successor, organization, or related companies or businesses, other participants, participating or sponsoring municipalities, governmental agencies, international organizations, agencies, sponsors, or advertisers, the representative administration, officers, directors, agents, representatives, employees or volunteers of such entities or organizations, the successors, heirs, assigns, or the insurers or representatives, be it personal or business, of each aforementioned individual.

(c) Owners, lessors and lessees of premises used to conduct the Games FROM ANY AND ALL LIABILITY FOR INJURY; INCLUDING DEATH, LOSS OR DAMAGE TO PERSON OR PROPERTY, OR ANY OTHER CONSEQUENCES in connection with entry in or arising out of participation in, performance in or lack of performance in, including travel in route to and from the Games.

(3) I FURTHER AGREE THAT

(a) Prior to participating as an athlete, I, or in the case of a minor, a parent or guardian, will INSPECT the facilities and equipment to be used, and if I believe same to be unsafe, I will immediately REPORT such condition(s) to the athletic coach, supervisor, or official connected with the Games of same and either DECLINE TO PARTICIPATE or ASSUME THE RISK of participating.

(b) I will ALLOW my PHOTOGRAPH, PICTURE or LIKENESS and/or VOICE to APPEAR in any official documentary, promotional (including any all advertisements), television, and radio, or film coverage of the Games, WITHOUT COMPENSATION.

(4) I CONSENT TO ALL EMERGENCY MEDICAL TREATMENT as may be deemed appropriate under existing circumstances by medical personnel or personnel associated with the Games.
