

Terms and Conditions Governing i*Trade@CIMB Bonanza Campaign 1 March 2012 – 31 Aug 2012

Campaign Period

1. The i*Trade@CIMB Bonanza Campaign 1 March 2012 – 31 Aug 2012 (“**Campaign**”) is organised by CIMB Investment Bank Berhad (“**CIMB**”) and will run from 1 March 2012 to 31 August 2012, both dates inclusive (“**Campaign Period**”).

Eligibility

2. Subject to Clause 3, the Campaign is opened to new and existing Individual Trading Account clients of CIMB who:
 - (a) Trade online and/or offline for local and/or foreign markets; AND
 - (b) Have signed up to receive contract statements via email (“**E-Contract**”), in each case within the Campaign Period (“**Eligible Participants**”).
3. The following shall not be eligible to participate in the Campaign:
 - (a) Clicks Trader, Trader Deposit, Islamic Stockbroking clients, Corporate clients; and/or
 - (b) Permanent and/or contract employees of CIMB (including its subsidiaries and/or related companies) and/or their immediate family members (i.e. spouse, children, parents, brothers and sisters); and/or
 - (c) Representatives and/or agents (including advertising & promotion agents and technology vendors) of CIMB and their immediate family members (i.e. spouse, children, parents, brothers and sisters); and/or
 - (d) Individuals below the age of 18 years as of 1 March 2012.

The Campaign

Monthly Top 10 Contest & Monthly Lucky Draw

4. Ten (10) Eligible Participants with the highest gross monthly brokerage generated through trading accounts with CIMB in the monthly periods of 1 March 2012 to 31 March 2012, 1 April 2012 to 30 April 2012, 1 May 2012 to 31 May 2012, 1 June 2012 to 30 June 2012, 1 July 2012 to 31 July 2012 and 1 August 2012 to 31 August 2012 will each be rewarded with a monthly prize (“**Monthly Top 10 Winners**”).
5. Five (5) Eligible Participants randomly selected as Monthly Lucky Draw winners via an automated selection system in the monthly periods of 1 March 2012 to 31 March 2012, 1 April 2012 to 30 April 2012, 1 May 2012 to 31 May 2012, 1 June 2012 to 30 June 2012, 1 July 2012 to 31 July 2012 and 1 August 2012 to 31 August 2012 will each be rewarded with a monthly lucky draw prize (“**Monthly Lucky Draw Winners**”).
6. Monthly Top 10 Winners for a particular month are not qualified to be the Monthly Lucky Draw Winners for that same particular month and are also not qualified to be the Monthly Top 10 Winners and Monthly Lucky Draw Winners for other months within the Campaign Period.
7. Monthly Lucky Draw Winners for a particular month are not qualified to be the Monthly Top 10 Winners for that same particular month and are also not qualified to be the Monthly Top 10 Winners and Monthly Lucky Draw Winners for other months within the Campaign Period.

8. However, all Monthly Top 10 Winners and Monthly Lucky Draw Winners can accumulate entitled entries to qualify in Grand Bonanza Lucky Draw at the end of the Campaign Period.

Grand Bonanza Lucky Draw

9. At the end of the Campaign Period, eight (8) Eligible Participants who are selected as Grand Bonanza Lucky Draw winners via an automated selection system will each be rewarded with a Grand Bonanza Lucky Draw prize (“**Grand Bonanza Winners**”).
10. Eligible Participants must accumulate the entry(ies) to qualify for Grand Bonanza Lucky Draw.
11. On a daily basis, Eligible Participants will be entitled one (1) entry for end-of-day brokerage fees of RM50.01 to RM100.00; or two (2) entries for end-of-day brokerage fees of RM100.01 to RM500.00; or three (3) entries for end-of-day brokerage fees of RM500.01 and above, in each case generated through trading accounts with CIMB within the Campaign Period.
12. Each Eligible Participant is only entitled to a maximum of three (3) entries each day within the Campaign Period.
13. However, there is no maximum number of entries imposed on each Eligible Participants at the end of the Campaign Period.
14. Notwithstanding Clauses 10, 11 and 12, one (1) bonus entry will be given to each:
- (a) new Individual Trading Account opened with E-Contract sign-up (ST Direct or ST Nominees account) with CIMB; or
 - (b) existing Individual Trading Account clients of CIMB who sign up for E-Contract, In each case during the Campaign Period.
15. At the end of the Campaign Period, eight (8) Grand Bonanza Lucky Draw prizes will be awarded to eight (8) winners.

For Monthly Top 10 Contest and Grand Bonanza Lucky Draw, should the Eligible Participants have more than one (1) trading account maintained with CIMB (e.g. ST Direct, ST Nominees, Share Margin Finance, etc), then all the brokerage or the brokerage fees (as the case may be) generated through such accounts with CIMB will be consolidated and taken into account as one (1) trading account with CIMB for eligibility for the Prizes.

24. CIMB has the sole discretion to fix the appointed date and time to make the telephone calls to the Winners.
25. CIMB will notify all Winners based on the information supplied by the Winners and maintained in CIMB's records. It shall be the Eligible Participants' responsibility to ensure that their phone numbers provided are current and updated with CIMB in the event of any changes being made to the same by the Eligible Participants.

Eligible Participants agree and authorise CIMB to forward the Winners' details (name, IC, telephone number, address) to the distributor/agent who would then contact the Winners regarding the delivery of their Prizes. In no event will CIMB be liable for any loss or damages (including without limitations, loss of income, profits or goodwill, direct or indirect, incidental consequential, exemplary, punitive or special damages or any party including third parties) howsoever arising whether in contract, tort, negligence or otherwise, in connection with the Campaign, even if CIMB has been advised of the possibility of such damages in advance, and all such damages are expressly excluded.
31. All Winners of the Monthly Top 10 Contest & Monthly Lucky Draw and Grand Bonanza Lucky Draw hereby expressly consent to CIMB at its discretion publishing, displaying, identifying their names, photographs, addresses, NRIC numbers and other information for advertising and publicity purposes.

The Winners of the Monthly Top 10 Contest & Monthly Lucky Draw and Grand Bonanza Lucky Draw hereby agree that they will at CIMB's absolute discretion be required to attend and participate in prize-giving ceremony(ies) and/or other related events organised by CIMB (if any) and if any of the Winners fail to attend such ceremony(ies) and/or events, CIMB reserves the right to forfeit the Prizes and/or select another winner.
33. CIMB reserves the right to cancel, terminate or suspend the Campaign with or without any prior notice. For avoidance of doubt, cancellation, termination or suspension of the Campaign shall not entitle any of the Eligible Participants to any claim or compensation against CIMB or any losses or

damages suffered or incurred by the Eligible Participants as a direct or indirect result of the act of cancellation, termination or suspension.

CIMB reserves the rights at its absolute discretion to vary (whether by addition, deletion, modification, amendment or otherwise howsoever) (the "Amendment") any of the terms and conditions herein at any time. The Amendment shall be effected at CIMB's absolute discretion through any one of the following means of communication, namely, by ordinary mail to the Eligible Participants' last known address or by posting a notice regarding the Amendment at each of CIMB's branches or by effecting an advertisement regarding the Amendment in any one newspaper of CIMB's choice, or via CIMB's website and the Amendment shall be deemed as binding on the Eligible Participants as from the date of notification of the Amendment or from such other date as may be specified by CIMB.
35. These Terms & Conditions, as may be varied or amended from time to time pursuant to Clause 34, shall prevail over any provisions or representations contained in any other promotional materials advertising the Campaign.
