Regarding: Compulsion to buy SIM Cards and Recharge coupons from Dr. Sukhdev Singh, Head of the department of GNDU, Amritsar.

(What is so special with Sukhdev singh's slim and trim wife that we, all the students and teachers, have to go to her home during the absence of Sukhdev Singh for getting our mobile numbers recharged; and sim cards, purchased?)

**(WE ARE THE STUDENTS OF PHYSICAL EDUCATION AND NOT MBA
(MARKETING), MIND IT!**

Sirs,,

We are the students of B.P.Ed and M.P.Ed of GNDU, Amritsar. Since Dr. Sukhdev Singh, Head of the department, by virtue of his official position, holds dominance over the students and other teachers including part-timers and research scholars, we are constantly under pressure to buy New SIM Cards, replace the existing SIM cards under mobile portability plan and get recharge coupons and paid recharges from him.

(1) Dr. Sukhdev Singh, who always looks for opportunities for easy money without doing anything, had earlier made thousands of members for a Multilevel Marketing scheme called **RCM** the organizer of which is still absconding as such MLM Plans violate the provisions of RBI Act, FERA and Money Laundering Act. Dr. Sukhdev Singh had made millions of rupees through this MLM scheme because he had made it mandatory for all the students - current and past - and the faculty members to join it and then start buying every day to day item from RCM stores through Dr. Sukhdev Singh who used to buy in bulk. Since everyone had to buy household items, he was making it compulsory for all to give list of their routine items for purchase. It was a direct intrusion into the privacy of others because no one liked to let

others know about the items one purchases. Sukhdev Singh stopped enrolling new members after the arrest of the organizer of another MLM Plan in Delhi But ignorance of law is not an excuse...

Dr. Sukhdev Singh takes agencies/dealerships/franchises in the name of his semi-literate wife (a *Dai/mid-wife*, returned from Canada with her daughter after Sukhdev Singh caught her living in adultery with her Christian neighbourer, Smith Lochan, during his visit in 2013) and starts promoting it. If his daughter attains the age of majority, he will start taking agencies in her name too and we may have to suffer again. Our parents are not employed in Universities; they have to work hard to earn money and therefore they can not feed the mongrels like Sukhdev Singh who are working to get salaries without research, without delivering lectures exploiting the part time teachers. *The only dealership which failed till date was the MLM consisting of membership based on sale of Sanitary napkins and lingerie of one Ludhiana based company. Our Head of the department was such a fool as to know that female students can neither buy from the department nor sell such products.*

Now SIM Card sales and Recharges is the latest obsession with Dr. Sukhdev Singh. It is prohibited for University staff to participate in any kind of business or employment during and apart from regular job. All the professors are equally prohibited to use their official dominance and influence to promote the business of family members. If you calls for his explanation, he will try to hush up the matter by saying that the agency exists in the name of his wife. How can his wife be known to students, research scholars and teachers of our department that we all have to buy SIM Cards and pay money to Sukhdev Singh in advance for our mobile recharges? There are a lot of shops in every nook and corner, of the city, then what kind of special affection do we have with his wife that we have to go at her home to get our cell numbers recharged? Does his wife impart practical sessions of sports in the University ground due to which we all are acquainted with her? Even a prostitute/Call Girl/woman with loose moral character does not know so many people from one organization alone!

Until the VC and the Registrar charge part-commission from this heavy transaction of mobile recharges and SIM Card sales, there is no reason why such kinds of instances of corruption don't come to light and no inquiry is marked to unveil Sukhdev Singh's business interest in different marketing plans. When he recharges our cellphone through recharge Dummies (a mobile set with balance), cellular company logs the location of the dummy/transaction. You can know that every time the University area mobile tower is used for recharges whereas he lives in much away from the University. Mark an inquiry to some independent agency/ACB and let it obtain application forms from the cellular company to see the handwriting used for filling up the forms to start with. Whatever he has done falls within the purview of Prevention of Corruption Act. Let ACB handle it.

All the students are bound to have at least one SIM Card purchased from him and

we have to use the balance as early as possible so that we may have more recharges. Rich students get their numbers recharged daily for Rs. 100/- to impress him and to seek special favors. **At the end of every month, we have to explain the reason for low mobile usage to the Head of the department, Sukhdev Singh, because he always maintain a list (available in the drawer of his office table and a duplicate copy in the pocket of his shirt) and notes down in cellphone the amount with which all students recharge their cell numbers.** It is complete nonsense. *Who are you to force us to buy extra SIMs from him? Who are you to have such a Head of the department who forces us to get our existing plans shifted to the cellular company of his choice through him? Sometimes we have to use another Company because of their wide network but we are constrained to use his SIM Cards poor service.*

Everyone gets net pack (1GB) every month. According to Sukhdev Singh, consumption for using whatsapp and facebook is only around 500 GB and asks us to recharge Net Pack with 500 MBs bandwidth which is expensive because we have to surf websites too. **Can you rein in this scum of the earth, please? If you are so interested about us, why don't you grant Canteen contractors a right to vend SIM Cards and recharge our phones within the University?**

(2) Dr. Sukhdev Singh never teachers us - he neither delivers any Lecture nor does he teach us during practical classes in the evening. **Officially his names appears in the time-table but in reality our senior students impart practical classes to us in the evening; part-timers and research fellows teach us theory classes in the morning and afternoon.** GNDU - A 5-star University with a difference? Different it is, but because of the idiots and greedy professors like Sukhdev Singh.

(3) Recently, Dr. Sukhdev Singh had called Dr. G.S.Kang, Principal of Khalsa College of Physical Education to conduct viva voce exam of a Ph.D. Candidate who was very close to Dr. Sukhdev Singh and doing Ph.D. Under his supervision. **Dr. Kang refused to pass the student as the candidate did not answer even a single question.** Dr. Kang stood by his decision but Sukhdev Singh picked up a verbal duel with him in front of students and teachers. **Ultimately, Dr. Kang, being alone as an external person, yielded before Sukhdev Singh and cleared the viva voce of the candidate who had to be declared failed.** This is the standard of evaluation, Ph.D.s and the status of teachers of GNDU!

Since Dr. Sukhdev Singh has to remain the Head of the department till his retirement and is eyeing on the post of a professor lest it should get filled up from an outsider paving way for his removal from the post of Head of the department. This is the reason he is exploiting the students and part-time teachers too the hilt.

(3) Our HRD Minister talks about bringing Indian universities amongst the list of top-200 Universities of the world. Are you sure that Samriti Irani can really succeed in her mission so long as the deadwood and greedy professors like Sukhdev Singh, Head, Physical Education, are working in the Universities?

All our teachers are very happy that your days in the University are numbered and you may retire without any further extension. But we don't know what purpose is going to be served after your retirement. Are you charging extremely high commission in comparison to someone else whom Sukhdev Singh is expecting as the next VC?

We are the students of B.P.Ed/M.P.Ed and not MBA (Marketing) for which we are being forced to buy SIMs and find the customers for new SIM Cards. By the way, Sukhdev Singh's "MAST lingerie" product is such that not even the students of MBA would like to sell. Why don't you kick this asshole out of the University to enable him to find suitable job as a Marketing Executive for sale of Cellular products?

Please direct Sukhdev Singh to stop forcing us to buy SIM Cards and get recharges done through him. It'd be better if he uses this energy in teaching us in the department. There is an urgent need of **CCTV Camera in our department in academic interest - in the lobby to monitor the ingress and egress of teachers from the classes**, failing which we shall continue to be taught by seniors from the petty, unprescribed books of low level authors.

The post of a Professor is dying vacant in the department for a long time but in that place, adhocists and part-timers are being accommodated. What's the personal interest of the VC for which that post has not been filled up from external candidate a la other departments for which the VC advertised the positions and appointed outsiders as the professors of this University? Appointing a professor will go a long way to curb the corruption of Sukhdev Singh and to prevent the exploitation of part-timers and adhocists apart from regulating and enforcing the academic affairs strictly with discipline.
