I have to be here on Thursday for a hearing on odds and ends. [Allie Overstreet](#) is supposed to answer the interrogatories and produce documents tomorrow, as she was court-ordered to do.

So, I can't leave for Missoula Montana until Friday. I plan to arrive in Missoula on Sunday, so filming will begin on August 5, and I will be there until at least the 12th. I will be filming the pilot for a proposed [Lawless America](#) TV series. This episode will be an expose of cyber stalker [Sean Boushie](#), the University of Montana, and the seemingly incompetent or corrupt law enforcement officials who have allowed this man to run wild on the Internet.

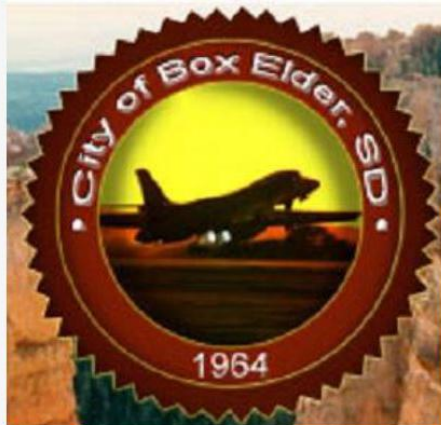
