Dear Boater,

Thank you for contributing to the success of our 18th season at Plattsburgh Boat Basin! We are very pleased with the continuing number of compliments on both appearance and services. You can be sure that PBB is dedicated and striving for 100% satisfaction as more improvements are in the works for 2015.

Attached is the 2015 Summer Reservation Contract. Please note that we are again offering a choice of two payment plans, both requiring a 10% deposit. The rate for the 2015 boating season is \$75/ft for docking if signed with a 10% deposit by September 15, 2014. Effective 9-16-14 the rate will be \$80/ft excluding A, (20' fingers) E and G docks which will remain at \$75/ft. Please note that 32' fingers on the south side of A dock will be at \$80/ft. Moorings are at \$55/ft if reserved by 9/15/14 also with a 10% deposit. All remaining docks/moorings will be filled starting 9-16-14.

All boats in the marina will be charged a minimum of the length of your dock you are assigned to, regardless of the length of your boat unless it is a decision of the marina because of special conditions.

In order to encourage PBB winter storage customers to be ready to launch on time, we will start charging summer storage on May 16th at a rate of \$.12/ft/daily unless we are unable to fulfill your requested date to launch.

In the past our policy has always been (please refer to p.2 of the contract) to use your dock or mooring for transient boats. We only use your space if you advise PBB that you are leaving overnight. Not everyone does this. Due to the limited docks/moorings we have for transient boaters we will be enforcing our charge of (\$2/ft x boat length) to you if you do not advise us that you will be leaving. In 2009 we introduced the "Premier Dockage/Mooring" - for an additional \$10/ft you will have exclusive use of your space and we will not use it for overnight boaters. When paying the deposit please let us know if you like to use the Premier option.

As an incentive for winter storing with us, we discount 10% from the winter storage rate if you pay on or before the haul out date. 2014 Fall/Winter Reservation forms are now at the store. Please be reminded that prices are subject to change after October 1st, 2014.

This year we now have parking passes - 1 pass for the boat owner's vehicle and the 2nd pass will be for a guest vehicle. The pass must be displayed at all times. If you have not received your parking pass please check in with the marina office. If a vehicle is towed due to improper parking it will be at the owner's expense.

Year-round patronage is essential to enable us to continue to provide you with the service you deserve. So reserve now and pass on the information regarding our rates to your friends!!

If there is anything we can do to make your summer at PBB more enjoyable please let us know. As always, your comments and/or concerns are appreciated.
