Priority Mail Service Instructions

1. Priority Mail Shipping supplies are available online at www.usps.com or your local Post Office.
2. Verify that all information populated on each of the copies is valid.
3. Commercial senders: supply the following information to assist Customs in processing the items.
 - a. If known, enter the 6-digit HS tariff number, which must be based on the Harmonized Commodity Description and Coding System developed by the World Customs Organization. "Country of Origin" means the country where the goods originated - e.g., were produced/manufactured or assembled.
 - b. If your item is accompanied by a license, a certificate and/or an invoice, enter the number.
4. Fold or cut out all copies in half and arrange in numerical order with the "1-Customs Declaration" copy on top. Copies must be placed into the PS Form 2976-E, Custom's Declaration Envelope - CP 91 (plastic envelope).
 - a. Affix the plastic envelope to the package on the address side.
 - b. Envelope must not wrap around the package edges.
 - c. Ensure that the entire barcode and all information is visible.
 - d. If using Carrier Pickup, retain the Sender's Copy then arrange remaining copies in numerical order with "1-Customs Declaration" copy on top. Copies must be placed into the PS Form 2976-E, Customs Declaration Envelope - CP 91 (plastic envelope).
 - e. If you choose to purchase postage or special services at a U.S. Postal Service® retail outlet, place copies in PS Form 2976-E. The retail associate will complete the labels, and provide you with the Sender's Copy.
5. Insurance purchased online cannot be combined with additional insurance purchased at the Post Office.
6. To mail:
 - a. International packages may NOT be placed in a USPS® collection box. Please present to retail associated in a U.S. Postal Service retail outlet, hand to your letter carrier at the time of mail delivery, or schedule a carrier pickup online at www.usps.com/p
 - b. Item must be mailed on the mailing date selected.
7. Each shipping label number is unique and cannot be reused. **ONLY THE ORIGINAL LABEL CAN BE ACCEPTED.**

Priority Mail International Indemnity Coverage:

Indemnity for uninsured Priority Mail International is provided only in accordance with postal regulations in the Domestic Mail Manual® (DMM) and the International Mail Manual® (IMM). Indemnity coverage is subject to both U.S. Postal Service® regulations and the domestic regulations in the destination country. Based on the weight indemnity coverage up to \$300 may be included at no additional charge, and may not be available to some countries. Indemnity for loss, damage, or rifling is limited to the lesser of the actual value of the contents or the maximum indemnity based on the weight of the article.

Priority Mail International Insurance:

International insurance coverage is subject to both U.S. Postal Service regulations and the domestic regulations of the destination country. Insurance coverage varies by country and is not available to some countries. The addressee must report damage of an insured article's contents at their local Post Office.

Note: Priority Mail International Indemnity or Insurance is not available for the Priority Mail International Flat Rate Envelope.
