

TRILLER DRAKE “SUMMER SIXTEEN” CONTEST

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OPEN TO LEGAL RESIDENTS OF THE UNITED STATES (EXCLUDING PUERTO RICO THE U.S. VIRGIN ISLANDS, AND OTHER COMMONWEALTHS, TERRITORIES AND POSSESSIONS), 18 YEARS OR OLDER.

1. By entering the TRILLER DRAKE “SUMMER SIXTEEN” CONTEST (the “Contest”) and accepting the terms herein, you agree to be bound by the following rules (“Official Rules”), which constitute a binding agreement between you, on one hand, and Triller, Inc. (“Sponsor”), on the other. The Sponsor, and any website companies hosting and promoting the Contest, their respective parent companies, affiliates, subsidiaries, advertising and promotion agencies, and all of their agents, officers, directors, shareholders, employees, and agents are referred to as the “Contest Entities”. These Official Rules apply only to the Contest and not to any other sweepstakes or contest sponsored by Triller, Inc.
2. **ELIGIBILITY:** This Contest is open only to legal residents of the United States (excluding Puerto Rico, the U.S. Virgin Islands, and other commonwealths, territories and possessions) 18 YEARS OR OLDER as of the date referenced below as the start date for the Contest (“Entrants”). If you are under the legal age of majority in your state of residence (a “Minor”), one of your parents or legal guardians must submit a signed, written statement that they have read, understood and agree to these Official Rules with your Entry (as hereinafter defined), and that such agreement constitutes acceptance of these Official Rules on behalf of you and themselves. Employees, and their immediate families (spouses, parents, children, siblings, and their respective spouses), including household members of Contest Entities are not eligible to enter. **VOID IN PUERTO RICO, OUTSIDE OF THE UNITED STATES, AND WHERE PROHIBITED BY LAW.** By entering this Contest, each Entrant agrees to release and hold harmless Contest Entities from any injury, loss, death, damage, action, claim, demand or other liability that may occur from Entrant’s participation in this Contest or from the acceptance, use or misuse of any prize awarded, or attendance at any event. 3. **HOW TO ENTER:** This Contest begins at 12:01am ET on Friday, May 6, 2016 and ends at 11:59:59pm ET on Friday, May 13, 2016. Enter the Contest via <http://triller.launchrock.com> May 6, 2016 – May 13, 2016 Step 1: Enter email address on <http://triller.launchrock.com>. Step 2: Successfully refer 3 other individuals who enter their email addresses at <http://triller.launchrock.com>. Phase 2: May 13, 2016. A Sponsor representative (in their sole and absolute discretion) will review the Entries and randomly select (1) winner from a pool of eligible Entries. Contest Entities assume no responsibility for any computer, telephone, cable, network, satellite, electronic or Internet hardware or software malfunctions, failures, connections, availability, or garbled or jumbled transmissions, or service provider/Internet/website/use net accessibility or availability, traffic congestion, or unauthorized human intervention. Sponsor reserves the right to modify, suspend, or terminate the promotion in whole or in part by giving such notice, in any form and manner deemed appropriate by Sponsor. Should promotion be modified, suspended, or terminated as aforesaid, the prizes will nevertheless be awarded from eligible Entries previously received and in accordance with these Official Rules.
4. **CONDITIONS OF ENTRY:** An eligible Entry must be received via online as described above. Incomplete Entries are void. By entering, Entrants agree to comply with these Official Rules, including all eligibility requirements. To enter, your computer must accept cookies, or any successor or similar technology (now known or hereafter devised or discovered), which may be used by Sponsor for the purposes of Entry tracking and as set forth in Sponsor’s on-line privacy policy, which can be found at <http://privacypolicy.umusic.com/terms/>. An Entry will be deemed to have been submitted by the authorized account holder of the e-mail address from which the Entry is made. Sponsor is not

responsible or liable for lost, stolen, mutilated, incomplete, incorrect, delayed, late, interrupted, illegible or misdirected Entries. All Entries become the property of Sponsor and will not be returned.

5. **DETERMINATION OF THE WINNERS:** The Winners will be selected from among all eligible online Entries received by the deadline date based on the selection process set forth in paragraph 3 above. Selection of the Winners shall be conducted under the supervision of the Sponsor. Sponsor will notify the potential Winners by phone and/or email on or around May 13, 2016. If the Grand Prize is won by a Minor, the Grand Prize will be awarded in the name of the Winner's parent or legal guardian in trust for the Minor. Sponsor reserves the right, at Sponsor's sole discretion, to disqualify any individual for any reason, including, but not limited to, those individuals Sponsor finds, in Sponsor's sole discretion, to be tampering with the entry process or the operation of the Contest or web site; to be in violation of the terms of service of the Contest Entities' web site; to be acting in violation of the Official Rules; or to be acting in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, macro, programmed, or like entry methods will void all such Entries by such methods. In the event of a dispute as to Entries submitted by multiple users having the same email account, the authorized subscriber of the email account used to enter the Contest at the actual time of the Entry will be deemed to be the participant and must comply with these Official Rules. Further, in any such dispute, under no circumstances will Entrant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental, nor consequential damages, or any other damages, including attorney's fees, other than Entrant's actual out-of-pocket expenses (i.e., costs associated with entering this Contest), and Entrant further waives all rights to have damages multiplied or increased.
