

## Lavazza UK - Wilderness Festival 2016 - Competition - Terms & Conditions

### **How to enter:**

  - b. For Facebook, you must tag @LavazzaUK in your entry to be eligible to win.

### **Terms & Conditions:**

- Open to residents of the United Kingdom, the Republic of Ireland, the Channel Islands and the Isle of Man aged 18 or over, except employees of the Promoter and their families, its agents, contractors or anyone professionally connected with the promotion.

- The closing date for entries is August 1st (midnight BST).
- Multiple entries are allowed. Incomplete or otherwise ineligible entries will be disqualified.
- All entries must be made by the entrant themselves. Bulk entries made from trade, consumer groups or third parties will not be accepted. Incomplete or illegible entries, entries by macros or other automated means (including systems which can be programmed to enter), and entries which do not satisfy the requirements of these terms and conditions in full will be disqualified and will not be counted.
