Dear Mr. Lawson:

This is to let you know that your **Individualized Plan for Employment (IPE)** has ended and your case was closed on 7/25/2016 because transportation not feasible or available.

We discussed this closure with you and found that given your situation without regular, reliable transportation, you are not available for work either currently or in the future after you finish your degree through Empire State College. As I stressed, ACCES-VR wishes to assist you but without reliable transportation, we very unfortunately cannot assist until there is a change in your situation. I did double check to see if STAR was an option and confirmed you live too far off the established bus route to qualify.

If your circumstances change, please contact me.

If you do not agree with this decision by ACCES-VR, you have the right to ask for a review of the decision through an informal meeting, administrative review, mediation or impartial hearing. A request for a review must be made within 90 days of the date of this letter.
