Resolution E.C.C. 1000 – Motion for the Addition of Member Erin Gallella – *rejected 4-1.*

Resolution E.C.C. 1001 – Motion for the Addition of Member Brooke Macinnes – *passed unanimously.*

Resolution E.C.C. 1002 – Motion for the Addition of Member Matthew Perron – *passed unanimously.*

Resolution E.C.C. 1003 – Motion for the Repeal of E.C.C. 1001 and the removal of Member Brooke Macinnes – *passed unanimously.*

Resolution E.C.C. 1004 – Motion for the Addition of Member Sean Whelton – *rejected unanimously.*

Resolution E.C.C. 1005 – Motion for the Addition of Member Riley Frost – *rejected unanimously.*

Resolution E.C.C. 1006 – Motion to Convert the Chat from Kik to iMessage – *rejected 4-3.*

Resolution E.C.C. 1006.1 – Re-Proposal of E.C.C. 1006 – *passed 4-1.*

Resolution E.C.C. 1007 – Motion to Replace Member Chad Boschetti with Brandon Tang – *passed 4-1.*

Resolution E.C.C. 1008 – Motion to Ban All Talk of Julia Cafferty's Hypocrisies Outside of the ECC Chat – *passed 4-1.*



Resolution E.C.C. 1009 – Motion to tax all Members of ECC \$1.25 in order to obtain a larger audience of Social Media Followers – *rejected 4-1.*

Resolution E.C.C. 1010 – Motion to Ban All Memes That are Deemed “Not-Dank” from the Chat – *passed 4-1.*

Resolution E.C.C. 1011 – Motion to Ban Member Cam Grace from Proposing Motions – *rejected 5-1.*

Resolution E.C.C. 1012 – Motion to Require a Majority Vote of The Board for a Post on the Instagram Account “rogue_chipmunk11” – *passed unanimously.*

Resolution E.C.C. 1013 – Motion for the Repeal of E.C.C. 1002 and the Removal of Member Matthew Perron – *redacted.*

Resolution E.C.C. 1014 – Motion for the killing of Mr. Fronduto by pushing him off the Empire State Building after stabbing his eyes and cutting his limbs off – *rejected 4-2.*

Resolution E.C.C. 1010.1 – Clarification of E.C.C. 1010: (a) “Not-Dank Memes” will be defined by a Majority Vote of The Board of ECC. (b) All uses of a Banned Meme prior to the Vote on said Meme will be immune from any punishment for violation of this Resolution – *passed unanimously.*

Resolution E.C.C. 1015 – Amendment that establishes Seniority or perceived Rank on The Board holds no weight in the Suffrage of Votes – *passed unanimously.*

Resolution E.C.C. 1016 – (a) Bans any sharing of ECC Documents outside of ECC (b) Permits retroactive punishment for violations of the aforementioned Clause – *passed unanimously.*

Resolution E.C.C. 1010.2 – Memes that originate in the ECC Chat are not subject to Vote on Dankness, and therefore are not affected by E.C.C. 1010 – *passed unanimously*

Resolution E.C.C. 1010.11 – Motion to deem “Doge Memes” as “Not-Dank” and ban said Memes from the ECC Chat on the grounds of E.C.C. 1010 and 1010.1 – *pending; 3-2 in favor.*

Resolution E.C.C. 1010.12 – Motion to deem “Box Memes” and any variation thereof as “Not-Dank” and ban said Memes from the ECC Chat on the grounds of E.C.C. 1010 and 1010.1 – *pending; 3-1 in favor.*
