1. Type of personal information collected

Personal Information: The type of personal information we collect or may include is set out on our store listing and app.

There are 22 App permissions that include location, network, wifi, headset, Bluetooth, Bluetooth admin., broadcast, camera, internet, read external storage, logs, phone, record audio, system alert, vibrate, wake lock, write external storage, C2D message, maps, receive, and read Gservices.

If we receive your personal information from third parties, we will protect it as set out in this Privacy Policy.

Disclaimer: the extent to which personnel will log information about an individual's access and use of the website is very limited.

2. Collection and use of personal information

We collect and use the personal information for purposes including to contact and communicate with you, for internal record keeping, marketing, customer service, and purchase confirmation emails.

3. Disclosure of personal information

We may disclose personal information for purposes including to provide our products and services to you, and as required by law. Stepping Stones Publications will not disclose personal information to overseas recipients or third parties external of the company.

Where we disclose your personal information to third parties for these purposes, we will request that the third party follow this Privacy Policy regarding handling of your personal information.
