

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. 1. SWEEPSTAKES. The RCA Antennas “The Big Game Sweepstakes” (“Sweepstakes”) begins on January 25, 2017 and ends on February 5, 2017 (known as the “Sweepstakes Period”). Voxx International, Inc., located at 150 Marcus Blvd. Hauppauge, NY (Voxx International), is the sole sponsor of the Sweepstakes.
2. ELIGIBILITY. The Sweepstakes is open to U.S. residents who are at least 18 years of age or older at the time of entry (“Entrant”). Employees of Voxx International and its affiliated companies, its advertising and promotion agencies, and the directors, officers, employees and agents of each of them and their immediate families and/or household residents are not eligible to enter. Voxx International is not responsible for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, access providers, computer equipment, software, failure of any email or entry to be received by Voxx International on account of technical problems or traffic congestion on the Internet or at any web site, or any combination thereof including any injury or damage to an Entrant’s or any other person’s computer related to or resulting from playing or downloading any materials in this promotion. 4. CONDITIONS OF ENTRY. Entrants may only enter once during each Sweepstakes Period.

5. SELECTION OF WINNERS. Sponsors clock will be the official time-keeper for all sweepstakes. Voxx International will select at random one entrant at the end of the Sweepstakes Period. Entrants are limited to one win during the Sweepstakes. Winners will be announced online on the RCA Antennas brand Twitter page. The winners will be notified by email within 24 hours of selection. If a winner does not respond within 24 hours of this notification to claim his or her prize, or if any winner does not meet the eligibility criteria, such winner will be disqualified and a new winner will be chosen. If, in Voxx International's opinion, there is any suspected or actual evidence that the integrity of each Sweepstake period has been compromised, Voxx International reserves the right to terminate the Sweepstakes and to award the prizes using all eligible entries received as of the termination date. Should the Sweepstakes be terminated prior to the stated expiration date, notice will be posted on the RCA Antenna's brand. The total VRV ("Verifiable retail value" defined as the price at which a promoter or sponsor can demonstrate that a substantial number of prizes have been sold at retail by a person other than the promoter or sponsor) of all prizes awarded during the Sweepstakes Period varies per antenna. Dollar amounts are expressed in U.S. currency. Odds of winning a sweepstakes will depend on the number of eligible entries received for the applicable sweepstakes.
