## SERVICES PROVIDED



### WEATHERIZATION

The EmPOWER Low Income Energy Efficiency Program (LIEEP), administered by the Maryland Department of Housing and Community Development (DHCD) helps low income households with installation of energy conservation materials in their homes at no charge. These improvements will both reduce a household's energy use and lower the monthly utility bills, and will also make occupants more comfortable and may improve the air quality and overall health of the family. ## Financial Counseling

## HOMELESS SHELTER & HOUSING PROGRAMS

## FOOD PANTRY
