SHIPPING REGULATIONS & POLICY

Please ship your frame via UPS or FedEx with signature upon delivery. Do **NOT** ship a handgun via USPS; only federally licensed dealers may ship a handgun/frame/receiver by USPS. You do not need to send the slide, unless you are getting Cerakote also. The package must NOT bear any markings that indicate the identity of the contents is a firearm. Please use the smallest box possible. (This will also save you money on shipping due to size/weight). You may need to present NAF Solutions' FFL information to the shipping service provider. Enclose a completed copy of the order form, a photocopy of your state issued ID, NAF Solutions' FFL, and any proof of employment for discounts. Please clearly address the package to: **NAF Solutions LLC, 2445 Commodore Blvd, West Melbourne FL 32904.** ATF regulation **does** allow us to ship your frame directly back to your home if your state issued photo ID or Concealed Carry Permit reflects your current residence; if it does **NOT**, we will need to ship your frame to a FFL dealer local to you, where you will be subject to a background check and the dealer's transfer fees. Please include the name and contact information of the dealer you would like it sent to. **If you are in California, and it needs to be returned through a dealer, I will need to obtain a Shipment Approval Number from the CA DOJ, and a \$25 processing fee will be added to your total.** If you are active military stationed somewhere, please include official documentation showing where you are stationed, and your address on location. NO P.O. boxes. We will return ship with adult signature confirmation. Direct shipments will be through common carrier (*FedEx/UPS*), shipments returned to dealers will be through USPS flat rate boxes. If you are not home when they attempt to deliver, you may have to pick up the package at a local location.





Change of Address (27 CFR 478.52). Licensees may during the term of their current license remove their business or activity to a new location at which they intend regularly to carry on such business or activity by filing an Application for an Amended Federal Firearms License, ATF Form 5300.38, in duplicate, not less than 30 days prior to such removal with the Chief, Federal Firearms Licensing Center. The application must be executed under the penalties of perjury and penalties imposed by 18 U.S.C. 924. The application shall be accompanied by the licensee's original license. The license will be valid for the remainder of the term of the original license. **(The Chief, FFLC, shall, if the applicant is not qualified, refer the application for amended license to the Director of Industry Operations for denial in accordance with § 478.71.)**

Right of Succession (27 CFR 478.56). (a) Certain persons other than the licensee may secure the right to carry on the same firearms or ammunition business at the same address shown on, and for the remainder of the term of, a current license. Such persons are: (1) The surviving spouse or child, or executor, administrator, or other legal representative of a deceased licensee; and (2) A receiver or trustee in bankruptcy, or an assignee for benefit of creditors. (b) In order to secure the right provided by this section, the person or persons continuing the business shall furnish the license for that business for endorsement of such succession to the Chief, FFLC, within 30 days from the date on which the successor begins to carry on the business.
