All wooden packages must contain IPPC stamp (INTERNATIONAL PLANT PROTECTION CONVENTION) and shippers must provide Original Fumigation Certificate, that must be available in Brazil upon arrival of goods. These information must be declared on HBL and MBL as specified in our SOP for sea shipments (item number 5.1) .</p>
