This event occurs in the City of Delray Beach, Palm Beach County, FL.

On 09/23/2014 at 1413 hours, I was dispatched to 1900 S Federal Hwy (Verizon) regarding a theft. Upon arrival I made contact with the store manager, Robert Cooke. Mr. Cooke, stated that on 09/22/2014 around 1700 hours an individual entered the store and asked to look at an iPhone 6. Sales associate, Martina Alfonso, met with Mr. Smith and showed him two iPhones. Martina went to the back of the store to change out a phone, and when she came back Mr. Smith was gone, along with one of the iPhones, valued at \$560.

The individual was identified as David Smith, whom was still inside the store at the time of my arrival. Mr Cooke stated that he called Mr. Smith and asked him to come back to the store on 09/23/2014, because they had video of him taking the iPhone from the store and wanted it back. Mr. Smith came back to the store and admitted to Mr. Cooke that he stole the iPhone and that he had sold it, and could not pay for it.

Upon entering Verizon I placed Mr. Smith into handcuffs, and advised him that he was under arrest for grand theft. I read Mr. Smith his Miranda rights, which he acknowledged, and verbally stated he understood. Upon asking Mr. Smith about the iPhone, he confessed that he came into the store, asked to see two iPhones and took one of the iPhones without paying. Mr. Smith then stated he sold the iPhone to an unsuspecting individual for \$300.

Due to the above stated facts, I find David G Smith in violation of FSS 812.014(2)(C)(1) Grand Theft; and FSS 812.019(1) Dealing in stolen property.
