

Fire Safety Manager

Fire Safety Manager (FSM) is a person/team who provides required services to prevent a premise from fire hazard. And, in case of fire accident the FSM takes necessary action to mitigate the casualties at lowest level.

Every year fire causes a great damage to the building owners. This results in damage to human resources, losing customer faith and financial loss. So, we have to avoid such incidents at any cost. It is the fact that, prevention is always better than cure. Hence, we can avoid injuries to human resources, expensive damages and potential fines by developing a fire prevention and awareness system.

Moreover, maintaining such system is not optional in Singapore. The Singaporean government is very much cautious about the fire safety of the country buildings. Therefore, the government has launched the Fire Safety Manager (FSM) Scheme. This law aims to maintain the fire safety standard for the buildings. Here, fire safety events and fire avoidance procedures are demonstrated through the FSM. This results in increase of fire safety awareness for the building residents.

There are few basics to be maintained by every premise to mitigate the risk of fire hazard of the building. Such as:

Ready the fire extinguisher: Fire extinguisher is an entry level fire defense device. It is worthy for extinguishing or controlling entry level fires. Though it is very useful in the emergency situation; but, if the fire goes out of control then it requires the skill of a **Fire Safety Manager**. The in-charge of building safety must be familiar of the location of the fire extinguishers. Just keeping a note or map is not enough; have to know the exact location and have to have training that, how to reach there in an emergency situation. Moreover, only keeping a fire extinguisher is not sufficient. Consequently, users have to ensure that the extinguisher is working efficiently. It is also a job of FSM to check the fire extinguisher including its pressure gauge to confirm this device will work at the time of requirement.

Ready Emergency Evacuation Plan: Every premise should have a backup exit for all inhabitants. And, also it is vital to maintain an emergency exit light at all levels. Moreover, an indicating light has to be functional to map the exit. This system will ensure minimizing the losses for the most valuable resources, human resource. Also, the occupants of these premises should have proper knowledge about this plan. It is a job of **Fire Safety Manager** to train the people for such situation.

Arrange regular fire drill: In every case, practice makes perfect. A fire drill is a rehearsal of the emergency actions to be used if fire occurrences happen. So, building safety in-charge has to arrange fire drill to train the occupants of the premise in the proper method. FSM has to arrange a fire drill at least once in a year. It will ensure that the inhabitants are ready to do what they have to in case of fire. Such drills can save lives if incident occurs.

By maintaining these strategies the premises owner can safeguard the facility and employees to be safe from fire hazard primarily. As the fire is a very sensitive case, it should be handled with utmost care. Here comes the role of a **Fire Safety Manager (FSM)**.
