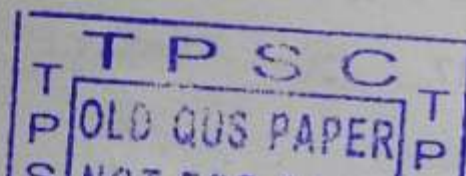

(b) A government residential quarter allotted to an officer may retain at normal licence fee after death for

(c) Recurring and non-recurring payment granted to a government servant from the Consolidated Fund of a State as remuneration for special work of an occasional means

- (i) salary  
(ii) special pay  
(iii) honorarium.

(d) Temporary post means a post carrying a definite rate of pay sanctioned for a
