I HEREBY REVOKE all Wills and Testamentary Dispositions heretofore made by me

1. I APPOINT ZELDA TOLLEY of 29A Queens Road Lexden Colchester Essex and
to be the Executrix and Trustee of this my Will

2. IN THE subsequent clauses of this my Will the expression "my Trustee" shall where the
context so admits mean and include the Trustee or Trustees hereof for the time being whether
original or substituted

3. I GIVE my entire estate both real and personal not specifically disposed of but after
payment of debts funeral and testamentary expenses and inheritance tax resulting from my
death (hereinafter called "my residuary estate") to my wife **DEBORAH COLETTE
FREEMAN** of Greenacres Waldingfield Road Chilton Sudbury Suffolk CO10 0PP
provide my said spouse is living at my death and survives me by 28 days but not otherwise

4. IF MY SAID SPOUSE is not living at my death or does not survive me by 28 days I
GIVE my residuary estate to my Trustees **TO HOLD** the same on trust to sell and convert
the same into money with power to postpone the sale and conversion thereof so long as they
shall in their absolute discretion see fit without being liable for any loss **UPON TRUST TO
HOLD** the proceeds of sale and any property for the time being unconverted for my two
children **FRANCESCA LOUISE FREEMAN** and **MATTHEW GEORGE FREEMAN**
until they shall attain the age of eighteen years

5. IN THE EVENT of my spouse dying in my lifetime I **APPOINT MR NEVILLE
SILVER** and **MRS MARINA KAREN SILVER** of 13 Maurice Walk London NW11 to
be the guardians of such of the children of my wife and myself as are minors

6. ANY EXECUTOR or Trustee for the time being hereof being a Solicitor or other
person engaged in any profession or business shall be entitled to charge and be paid (in

priority to all other dispositions contained herein) all usual professional or other charges for business done by him or his firm in connection with the proving hereof or the execution of the trusts hereof whether in the ordinary course of his profession or business or not and including business which an Executor or Trustee not being engaged in any profession or business could have transacted personally

7. MY TRUSTEES shall have the following powers in addition to their powers under the

General Law:-

- (a) To apply for the benefit of any beneficiary as my Trustees think fit the whole or any part of the income from that part of my estate to which he is entitled or may in future be entitled
- (b) To apply for the benefit of any beneficiary as my Trustees think fit the whole or any part of the capital to which that beneficiary and on becoming absolutely entitled shall bring into account any payments received under this clause
- (c) To insure against loss or damage by fire or from any other risk any property for the time being comprised in my residuary estate to any amount even though a person is absolutely entitled to the property and to pay all the premiums for any such insurance at their discretion out of the income or capital or my residuary estate or the property itself and so that any money received under any such insurance may be used at their discretion either towards making good the loss or damage in respect of which it was received or as if it were proceeds of sale of the insured property
- (d) To invest trust money and transpose investments with the same full and unrestricted freedom in their choice of investments as if they were an absolute beneficial owner and to apply trust money at any time and from time to time in the purchase with full vacant possession (upon trust for sale with full power to postpone sale) or in the improvement or repair of any freehold or leasehold house or other dwelling and to

permit the same to be used as a residence by any person or persons having an interest or prospective interest in my residuary estate upon the said terms and conditions from time to time as my Trustees in their absolute discretion may think fit.

8. I EXPRESS the desire that Messrs Lucas Baron Jacobs

of 600 Lea Bridge Road Leyton London E10 7DN or any firm which at the date of my death shall have succeeded to the practice of the said firm may be employed in all matters in connection with my estate
