9ES.


1. I revoke all former testamentary dispositions made by me.

3. 4. My Executors shall hold the remainder of my estate on trust either to retain or sell it on the following trusts:-

 - (b) To pay the residue as follows :-

 - (ii) 25% to my daughter the said DONNA TRACEY BARTLETT.
 - (iii) 25% to my son the said GLENN ROY GRAGG.
 - (iv) 20% to my partner the said GWENDOLINE PATRICIA CLARY.
 - (v) 5% to my son ROMAINE CARL CRAGG of 48B ANGEL STREET HADLEIGH SUFFOLK IP7 5EY.


